# VI-B. CONSULTANCY DEVELOPMENT CENTRE

## 1. PREAMBLE

CDC has made significant strides in emphasizing the need for effective use of consultancy services in various Central/ State Govt. Ministries/ Departments. Consolidating its position as a Centre for promoting and developing consultancy, CDC offers a vast range of services to Clients and Consultants.

During the year 2010-11, CDC undertook various activities keeping in view its mandate of promotion and development of Consulting Profession, Capacity Building, Creating trained human

#### 2. ACTIVITIES USING PLAN SUPPORT

During the year 2011-12, Plan support of 400

lakhs was provided by DSIR for carrying out the various projects/schemes and activities. To have seamless integration with Programmatic Cluster Driven Approach of the 12<sup>th</sup> Five Year Plan the various projects/schemes and activities were put under various programme clusters as given below:

- 3. MAIN HIGHLIGHTS OF VARIOUS PLAN PROJECTS / SCHEMES AND PROGRAMMES UNDERTAKING DURING 2010-11
- Capacity Building for use of consultancy services by Ministries /departments of Central/State Governments and client organizations

CDC carried out 37 programmes including programmes executed through TCOs on

- "Selection and Effective use of Consultants" and more than 700 Sr. Govt. officials of Central/State Govt./Ministries/ Departments were trained. Feedback of the participants was well received and it was recommended that CDC should continue conducting more number of such programmes in future as well.
- Exposure of Consultants and Clients to International Practices Including Seminars & Conferences.

Under this scheme, CDC extends financial assistance to Consultants for attending and participating in international conferences and seminars and assimilates knowledge about best practices in consultancy.

During the year 2010-11, Support was provided to Clients and Consultants in the following international conferences:

- a) FIDIC Annual Conference
- b) 16<sup>n</sup> World Productivity Congress
- c) TCDPAP Annual conference
  - Under the scheme, CDC provided support to 20 Senior Govt. officials/ Consultants for attending the FIDIC Annual Conference 2010 on 'Managing Innovation -The Way Forward' held from 19-22 September, 2010 in New Delhi.
  - Financial assistance was provided to five Senior Govt. officials and Consultants towards participation in the 16th World Productivity Congress held from 2-5 November, 2010 at Antalya, Turkey.
- Project for Mapping of Indigenous Technologies with state Govt, schemes for public services and utilities across sectors and identification of Consultancy interventions therein.

CSIR has developed a number of technologies in diverse fields such as Health, Building & construction, Chemical, Agriculture, Drinking Water and Information Technology which are in commercial use. They also have technologies which are available for commercialization.

Keeping in view that how the mapping of CSIR Technologies with State Govt. schemes for public services and utilities across sectors may take place to enhance the use of CSIR Technologies, CDC undertook a macro level study of demand of selected CSIR technologies among State Government users pertaining to these sector.

99 technologies listed in the Compendium of Technologies titled "Selected CSIR Technologies Focusing States of India" were considered for the study.

iv. Accreditation/ Certification and Empanelment of Consultants

> Realizing the fact that there is lack of awareness among various Client organizations (particularly Ministries / Govt. Departments / PSUs) about the capabilities and level of operation of Indian Consultants and subsequently, there is also need for enhancing quality in consulting, CDC has proposed an independent and objective system for the Accreditation of Consultants and Consulting firms.

- An Accreditation Advisory Committee(AAC) has been constituted for the purpose of grant of certificate of Accreditation.
- CDC has received a total of 136 applications (25 applications in the category of 'Individual Consultants' and 111 applications in the category of 'Consulting Firms'). The applications are under consideration of the Committee.
- First meeting of AAC was held on 25<sup>th</sup> March, 2011.
- v. Modifications in Manual for Selection of Consultants for Consultancy Profession

CDC has launched a scheme in 2009-10 on Capacity Building for use of Consultancy Services by Ministries/ departments of Central/ State Governments and Client organizations. The base documents used was "Manual of Policies and Procedures for Employments of Consultants" prepared by Ministry of Finance.

During these capacity building programmes feedback was received from participants based on their practical experience on some aspects which have not been comprehensively covered in the manual. Keeping this in view CDC undertaken a study on "Modifications in Manual for Selection of Consultants for Consulting Profession" with following objectives:

- Examine the Ministry Finance "Manual of Policies and Procedures for Employment of Consultants" available on Ministry of Finance website.
- Identify gaps vis-å-vis international practices particularly being adopted by Asian Development Bank, World Bank/FIDIC.
- Identify issues, concerns areas of both consultants and clients that hamper development and promotion of consulting in India

#### vi. Scheme for Women Consultants

With an endeavor to expose women experts in various disciplines of consultancy and to encourage them to take up consultancy as a career option, CDC evolved a scheme for Women Consultants. The scheme involves providing financial assistance to Women Consultants including subsidy for training, travel, infrastructure, etc for attending and participating in international seminars and conferences.

vii. Scheme for Fellowship to Students of Academic Institutions for carrying out Live Consulting Assignments

> The fellowship scheme was launched in 2009 with the objective of encouraging

professionals to venture into the field of consultancy. The scheme offers students pursuing BE/ B.Tech/ MBA or equivalent courses an opportunity to work on live consulting projects and learn consultancy skills during their educational programmes. The scheme also has a provision of providing cash incentives to successful candidates. A total of 27 Project proposals were received. 18 Cases granted permission to carry out projects and 3 Fellowship (of 10,000) granted to successful students.

# viii. Development of Technology Commercialization Experts

The programme aimed at inviting participation from Scientists/ Engineers/ Experts and Consultants seeking a role in technology commercialization and transfer activity within their own organization or as a new career opportunity or as a Free Lance Technology transfer specialists/ Consultants. The workshops of 3 days conducted at Hyderabad, Bangalore, Mumbai, Pune, Chennai, Nagpur and Delhi and was attended by a total of 162 participants.

ix. Study for Consultancy Export potential in CIS Countries (Russia, Kazakhstan, Belarus and Ukraine)

> The basic aim of the study was to find out and recommend mechanism to develop linkages with government agencies, prospective client organisations, local industry associations, trade missions, Consultants (individuals and firms), associations, chambers of commerce, etc.

x. Identification of S&T interventions and skill development in NE/J&K/LWE states and identification of consultancy interventions.

> The study aimed at identification of steps taken by Social groups and other organisations working towards the development of these states involving

Science and Technology interventions; Preparation of skill development plan based on the identified Science and Technology requirements and developing training programs on employability skills (involving science and technology interventions).

The study focused upon identifying the initiatives taken up by Central Government and the respective State Governments in the form of various Schemes.

xi. To prepare model DPR along with business models for use of Indigenous technologies R&D funded technologies for water purification for mass deployment.

The DPR was undertaken to examine the various aspects pertaining to indigenous technologies related to drinking water such as supply and demand gap, competitor technologies, commercialization projects, technologies gaps as well as to evolve strategy after consultative process with various stakeholders such as CSIR Scientists, Government officials, Manufacturers, NGO, Water Consultants. Final DPR submitted to DSIR.

xii. Consultancy Business Opportunities (CBO)

CBO is an electronic version of fortnightly business information bulletin and include the following:

- Consultancy opportunities available at home and abroad
- Emerging opportunities both at home and abroad
- Major forthcoming events
- Any other information conveyed by CDC from time to time

The daily email alert publication continued. All the consulting opportunities - both national and international are uploaded on the website.

 Project on Documentation of Case Studies/ Projects in Consulting.

> In order to supplement educational programmes in consultancy management and create a knowledge base of reference material in consulting, CDC proposed to develop a compilation of case studies documented by practicing consultants.

xiv. Knowledge Centre - Publication of reports, books, journals etc.

> CDC has published study report on various projects/ assignments carried out during the year. In addition to project reports, CDC has been regularly bringing out following publications:

### Consultancy Vision

Consultancy Vision" is a quarterly newsletter covering news, views, programmes and activities of the Centre and its members and is widely circulated to the members of CDC, Consultants and Consultancy organizations, Government departments, Multi-lateral Funding Agencies and Foreign Missions. Electronic version of the publications was started during the year 2007 and the same is disseminated through e-mail and uploaded on website.

## Consulting Ahead

Consulting Ahead" is a bi-annual journal of CDC. First issue of the journal was released in January 2007. This is the only journal in the country on Consultancy. Consulting Ahead is a source of innovative thoughts, knowledge and information of concern for Consultants, Clients, Policy Makers, Academicians and Professionals from various disciplines. Two issues of the Journal were brought out in July 2010 and January 2011 respectively.
