Extracts of Audit Observations by C&AG

Wasteful expenditure: The Regional Research Laboratory (RRL), Bhubaneswar imported a Differential Scan Calorimeter at a cost of Rs. 17.93 lakh. Though the equipment reached the Laboratory in December, 2000, it was inspected only in March, 2001 and found in damaged condition. RRL lodged a complaint with the insurance company in March, 2001 and registered a claim for Rs. 17.93 lakh in March 2002 after getting the equipment surveyed. The insurance company repudiated the claim in August, 2002 stating inter alia that RRL did not bring the matter to the notice of the carrier or other bailees within three days of delivery of the consignment according to the transit clause. RRL took up the matter with the foreign supplier in June, 2003 requesting for replacement of the equipment whose response was still awaited (November 2003). Thus, failure of RRL to get the consignment inspected immediately on its receipt resulted in wasteful expenditure of Rs.17.93 lakh.
