The appellant (Shri Ravindra Kumar Kashyap) was available via telephone conference call. DSIR was represented by Mr. Bhanu Surinder, HOD, DSIR & Mr. S S P Sinha, Under Secretary (respondent) and Mr. Vimal Kumar Varun, CPIO were present during the appeal.

2. The appellate authority noted that the appellant was not satisfied with the reply provided to him by the department against his RTI application No. DOSIR/R/X/21/00002 dated 15.05.2021. Therefore, the appellant in his appeal registration No. DOSIR/A/E/21/7 dated 23.06.2021 has asked to provide information sought by him in his RTI application No. DOSIR/R/X/21/00002 dated 15.05.2021.

3. The appellate authority could speak to appellant via telephone conference call. Appellate authority perused RTI application and noted that the appellant has sought desired information as in his RTI application.

4. Appellate Authority discussed the information as sought in RTI appeal. During the discussion respondent informed that draft report on identification of Posts in DSIR suitable for person with benchmark disabilities in terms of the provision contained in the RPWD Act, 2016 is under approval (copy attached).

5. Appellate authority after further discussion/deliberation gave a decision that appeal stands disposed of.
