New Delhi, the 23rd September, 1996

G.S.R. 427 .-- In exercise of the powers conferred by the provist to article 309 of the Constitution, the President hereby makes the following rules regulating the method of recruitment to the post of Junior Technical Assistant in the Department of Scientific and Industrial Research, namely :--

- 1. Short title and commencement.-(1) These rules may be called the Department of Scientific and Industriali Research, Junior Technical Assistant (Group 'C' post) Recruitment Rules, 1996.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of post, classification and scale of pay .- The number of the post, its classification and the scale of pay attached thereto, shall be as speeified in columns 2 to 4 of the Schedule annexed to these rules.
- 3. Method of recruitment, age-lingt, qualifications etc .- The method of recruitment, age-limit qualifications and other matters relating to the said post shall be as special in columns 5 to 14 of the said Schedule.

- The same of the sa 4. Disqualification .-- No person.
 - (a) who has entered into or contracted a marriage with a person having a spouse living, or
- (b) who, having a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post;

Provided that the Central Government may, if satisfied that such marriage is pennissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax .- Where the Central Government is of the opinion that it is necessary or expedient, so to do, it may, by order, for coasons to be recorded in writing relax any of the provisions of these rules with respect to any class or category of persons,
- 6. Saving .- Nothing in these rules shall affect reservations, relexation of age limit and other concessions required to be provided for the Scheduled Caste, the Scheduled Tribes, Ex-servicemen and other special categories of persons, in accordance with the orders issued by the Centrel Government from time to time in this regard.

- 5. Power to relax.— Where the Central Government is of the opinion that it is necessary or expedient so to do, it may by order and for reasons to be recorded in writing and in consultation with the Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving.— Nothing in these rules shall affect reservation, relaxation of age-limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, the Ex-servicemen, the Other Backward Classes and other special categories of persons in accordance with the orders issued by the Central Government from time to


