ORDER

Subject: Issuance of DSIR Registration certificate in respect of In-house R&D unit(s) of Industries and Scientific and Industrial Research Organizations (SIROs) recognized by DSIR with Revised validity up to the period coinciding with current recognition – reg.

DSIR is issuing 'Certificate of Registration' to Research Institutions other than Hospital viz., In-house R&D Units (RDI) of Industry and Scientific and Industrial Research Organizations (SIROs) up to 30.09.2024 as per Gazette Notification No. 07/2024-Customs dt 29.01.2024 wherein Notification No. 51/96-Customs, dated the 23rd July, 1996, published vide number G.S.R. 303(E), dated the 23rd July, 1996 was extended beyond 31.03.2024 up to **30.09.2024**.

2. Reference is now invited to the **Notification No. 38/2024-dated 23rd July, 2024** of Ministry of Finance (Department of Revenue), Government of India (copy enclosed), regarding amendment in various notifications to extend the validity of exemptions lapsing on 30.09.2024 up to **31.03.2029**.
3. In view of the above, it has been decided to **extend the validity of Registration up to the period coinciding with the validity of current Recognition** for all existing recognized In-house R&D Units (RDI) of Industries and Scientific and Industrial Research Organizations (SIROs) having valid recognition during the period and who's Registration Certificate is lapsing on 30.09.2024.
4. However, renewal of recognition of In-house R&D units of Industries and SIROs shall be processed by the department as per the existing guidelines and procedures duly laid down in DSIR.
5. This Order is issued with the approval of Competent Authority.
